2. Reservations must be made through the Apple Vacations Promotions Department. We regret that we are unable to accept reservation requests by phone or in person. Trip is non-refundable, non-transferable and cannot be exchanged for cash. Apple Vacations reserves the right to substitute the vacation with another on ENVF air and of equal value, equal rating or within the same hotel chain should any unforeseen circumstance occur.
